

TAX LEVY ORDINANCE

ROAD DISTRICT

ORDINANCE NO. 2017-6

An ordinance levying taxes for all road purposes for McLeansboro Township Road District, Hamilton County, Illinois, for the tax year 2017, collectible in 2018.

BE IT ORDAINED by the Board of Trustees of McLeansboro Township, Hamilton County, Illinois, as follows:

SECTION 1: That the Highway Commissioner of McLeansboro Township Road District on December 12th, 2017 does hereby determine and declare the sum of One Hundred Thirty Six Thousand Thirty Two Dollars and No Cents (\$136,032.00) are hereby levied upon all property subject to taxation within the Road District as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Road District as required by statute or voted by the people in accordance with the law, for such purposes as : Road and Bridge, Joint Bridge, Building and Equipment, Insurance and Permanent Road for the year 2017.

Section 2: That the amount levied for each object and purpose shall be as follows:
