

TAX LEVY ORDINANCE

TOWNSHIP

ORDINANCE NO. 2018-6

An ordinance levying taxes for all Town purposes for McLeansboro Township, Hamilton County, Illinois, for the tax year 2018, collectible in 2019.

BE IT ORDAINED by the Board of Trustees of McLeansboro Township, Hamilton County, Illinois, as follows:

SECTION 1: That on December 11, 2018, the sum of Two Hundred Forty Six Thousand Nine Hundred Forty Four Dollars and No Cents (\$246,944.00) are hereby levied upon all property subject to taxation within the Township as that property is assessed and equalized, in order to meet and defray all the necessary expenses and liabilities of the Township as required by statute or voted by the people in accordance with the law, for such purposes as: Corporate (Town Fund), Cemetery, General Assistance, Social Security, Insurance and Audit for the year 2018

Section 2: That the amount levied for each object and purpose shall be as follows:
